Library Tax Initiative

In the November 2016 election, the library tax initiative failed to meet the 2/3 vote of support needed to pass. However, in 2017, the California Supreme Court ruled that some tax initiatives brought by petition of the voters required only a 50%+1 majority to pass. Linda Fiddler, in Bakersfield, became the leader of a movement to bring a new initiative for a "library only" 1/8 of a percent sales tax to the ballot. She visited Ridgecrest in late May and a new group of R/C supporters began the task of collecting the signatures of registered Kern County voters in our area.

Renee Westa-Lusk got permission to collect in front of Wal-Mart, Albertsons, and K-Mart. With her, Robert Shaw, Dave Burdick, Penny LaPome, Sarah Wersan, Ed Schlesinger, and Peggy Johnson braved the heat and collected hundreds of signatures. Meanwhile, Carol Pearson, Vicki Siegel, Sandy Bradley, Elaine Wiley, Liz Babcock, Vickie Schauf, attended local events and collected additional hundreds. John Anderson, Marj Fairfield, Don Snyder, Mary Garback, Barbara Bane, Kristi West, Nadine Steichen, Ike Fujiwara, and other good library friends gathered more. In all, almost 2,500 signatures were delivered to Bakersfield from Ridgecrest.

Sadly, with such a short time to collect, we did not have enough by the June 2018 deadline. About 14,500 signatures were collected, but when allowance is made for the "usual" validity of petition signatures in Kern county, an additional 3,000 signatures must be collected to pass the Kern county Elections Department review and certification process. About 13,500 valid signatures are needed to qualify for inclusion of the LIFE initiative on the next available ballot (March 2020).

PLAN B: We can continue to collect until October.

We have several good options once the signatures qualify in the Fall.

- (1) We can ask the Supervisors to adopt (it doesn't go to the ballot it just becomes real). We might have new faces up there next year.
- (2) We place it on a future ballot (the signatures are good until the 2020 General).
- (3) We force a special election. This is costly and not recommended but it might be good 'encouragement' to get them to Adopt.)



Librarian's Corner

Summer is in full force both inside and outside the library! The high temperatures outside have been bringing many people inside to experience all that we have to offer. As usual, this summer we have at least one activity every day that we are open (even if it is "just" a scavenger hunt or our popular "I Spy" display case). Most activities are for children, but we had a few for teens and adults (crafts and workshops). We had some amazing visitors that packed our little library thanks to the Friends of the Kern County Library, Inc. (The Magic of Christopher Lopez and Roaming Reptiles) and the Friends of the Ridgecrest Branch Library (Omnipresent Puppet Theater, Wild Child Adventures Bubble Show, and Tutu's Shave Ice). We had visits from the Ridgecrest Police Department's K-9 and Traffic units and the Kern County Fire Department.

The Summer Reading Challenge theme is "Reading Takes You Everywhere!" and we incorporated the idea of "travel". We continue to offer a program that allows ALL ages to participate from babies through adults. Summer Reading Challenge runs through early August and we will do prize drawings for the HUNDREDS of prizes that have been generously donated by the Ridgecrest community on August 8. The next newsletter will have finisher numbers (including the Inyokern Elementary outreach location) and a list of all of the generous sponsors.

This was the first summer for Lunch at the Library, a partnership with Sierra Sands Unified School District to offer lunch between 11:30 am to 12:30 pm from Tuesdays through Fridays for six weeks. Lunches were FREE to all 18 and under (adult caregivers could buy a meal for \$3.75) and followed USDA standards. There were hot and cold entrees along with fruit & vegetable choices, and milk. We were fortunate enough to have an amazing group of volunteers who ensured that Lunch at the Library ran smoothly. I am incredibly proud to report that 1,244 meals were served to children, which is an average of 54 per day! We look forward to offering it again next summer and possibly expanding it to Inyokern Elementary.

We were asked to submit a proposal for funding from the Peck Family Foundation. In 2015, the Peck Family Foundation made it possible for us to replace all of the shelving for our Juvenile Fiction books. We've asked them to consider helping us replace existing shelving for our Juvenile Fiction and Young Adult uncataloged paperbacks/Young Adult new book display along with some tables in our Community Room. As you may (or may not) know, our Community Room is truly a multipurpose room and is used for Story Time, crafts, games, yoyo tricks, book discussion, movies, workshops, and the list goes on. The flip top tables (some with power access built in) will help us easily reconfigure the room.

We requested more graphic novels and easy readers for kids and teens in anticipation of the busy summer. We ordered finisher bags for all ages and will be providing some of the prizes (such as bluetooth speaker, 2T themed shirt, World of Snacks online gift certificate, and more). We were able to provide some wonderful performances and activities. Thanks to a partnership with a local sorority representing the Friends, the Summer Reading Challenge happened in Inyokern for the third summer!

So far, we've managed to accomplish some great things in the branch- a changing table in one restroom (ADA compliance issues prevented the installation of a second changing table), a flat screen TV for digital events scrolling, and new flip top tables in the main reading area which has made setting up for big performances so much easier. Keep an eye out as we are looking to make more changes still in 2018.


